SUBJECT: CONSTITUTION PARTY OF VIRGINIA CHAIRMAN OFFERS HIS PRAYERS TO THE FAMILIES OF THE VICTIMS AND THE VICTIMS IN THE VIRGINIA BEACH MASS SHOOTING STILL FIGHTING TO SURVIVE

Chairman of the Constitution Party of Virginia, John Bloom, offers his prayers and condolences to the families of the victims that were tragically killed and his prayers for those fighting to survive for a speedy recovery in the senseless mass shooting in the Virginia Beach Municipal Building. Mr. Bloom who was woken up by a Newport News Police Officer knocking on his door to ask him if he saw or heard anything concerning the shooting and killing of a young man, at a residence just two houses from where he lived, in the Denbigh Section of Newport News where gun fire is a common occurrence. Mr. Bloom offers this statement on the Virginia Beach Mass Shooting:

“To all those residents of Virginia that are concerned for their safety, to think rationally before considering any proposed legislation, such as “Gun Control” would taking guns from law abiding citizens prevent criminals from taking the life of even one man. “Gun Control” is NOT “Criminal Control.” It isn’t the National Rifle Association or my FRIENDS in the “Virginia Citizens Defense League” that prohibits the Federal and State Governments from abridging the rights of law abiding citizens from obtaining guns, it is the Constitution of the United States and here in Virginia the Constitution of Virginia. Though the 2nd Amendment of the Constitution prohibits the Federal Government from abridging the rights of the people to keep and bear arms, it is the 10th Amendment that restricts the powers of the FEDERAL Government to only those specifically delegated to it by the Federal Government. [Article 1, Section 13, The Virginia Bill of Rights](#), “That a well regulated militia, composed of the body of the people, trained to arms, is the proper, natural, and safe defense of a free state, therefore, the right of the people to keep and bear arms shall not be infringed;”

I suggest that Technology employed by both Virginia Law enforcement and VDOT to ticket motorists be made available to citizens to police their own neighborhood using webcams connected to the myriad of Light poles in their neighborhoods.
