SUBJECT: CONSTITUTION PARTY OF VIRGINIA CHAIRMAN CALLS FOR WITNESSES AND DOCUMENTARY EVIDENCE REQUIRED FOR A FAIR SENATE IMPEACHMENT TRIAL

John Bloom, Chairman of the Constitution Party of Virginia, issues the following statement in regards to the upcoming Senate Impeachment Trial:

“The House of Representatives found sufficient evidence to Impeach Donald Trump for Abuse of Power and Obstruction of Congress, NOW it is the responsibility of the United States Senate to Conduct the TRIAL. The Constitution Party of Virginia is neither Republican nor Democrat, but Americans that cares deeply about the Constitution of the United States, the Rule of Law and the rights of the individual Constitutional rights of ALL Americans. With the deep division within this country, it is imperative that all evidence, including RELEVANT documents and testimony, be brought forward in this trial, both inculpatory and exculpatory, if any exists. Irrelevant testimony that does not address either of the Articles of Impeachment should be disallowed by the Chief Justice of the Supreme Court of the United States, who will preside over this Impeachment Trial.

Citizens of the United States who remain loyal to America’s Constitutional Republic would desire to have their Representatives make an INFORMED decision based on “the TRUTH, the whole TRUTH and nothing but the TRUTH”.
