## SUBJECT: THE UNCONSTITUTIONAL PRESIDENT

The Constitution Party of Virginia will always defend, protect and preserve the Constitution of the United States and the Rule of Law. Under the US Constitution the President can fire officials in his administration but what he cannot do is replace them WITHOUT the "Advice and Consent" of the US Senate. Article II, Section 2, which reads as follows:

..."he shall nominate and by and with the Advice and Consent of the Senate, shall appoint Ambassadors, other Public Ministers and Consuls, Judges of the Supreme Court, and all other officers of the United States whose Appointments herein otherwise provided for and which shall be established by Law: but the Congress may by law vest the Appointment of such inferior officers as THEY think proper, in the President alone."

In addition to the appointment of Mr. Matthew Whitaker as Avcting Attorney General being OBVIOUSLY UNCONSTITUTIONAL, under <u>US Code Title 28 Paragraph 508</u> states the line of succession for the Attorney General, also violates US LAW:

- "(a) In case of a vacancy in the office of Attorney General, or of his absence or disability, the Deputy Attorney General may exercise all the duties of that office, and for the purpose of section 3345 of title 5 the Deputy Attorney General is the first assistant to the Attorney General.
- **(b)** When by reason of absence, disability, or vacancy in office, neither the Attorney General nor the Deputy Attorney General is available to exercise the duties of the office of Attorney General, the Associate Attorney General shall act as Attorney General. The Attorney General may designate the Solicitor General and the Assistant Attorneys General, in further order of succession, to act as Attorney General."

Congress needs to force Donald Trump to replace Matthew Whitaker with Deputy Attorney General Rod Rosenstein in accordance with the US Constitution and US Law or IMPEACH and remove him for office for violating the US Constitution and US Law.

America's Founding Fathers feared that American voters may ELECT a KING; therefore they RESTRICTED and LIMITED the powers of the President under Article II of the US Constitution. He could not sign Executive Orders like a King signed Royal Proclamations changing or creating laws and though the President can FIRE personnel at will, the President is required to have the "Advise and Consent" (confirm) of the Senate for "all other officers of the United States." It is up to CONGRESS, both Democrats and Republicans to stop this **UNCONSTITUTIONAL President** from continued violations of the US Constitution and restrict his powers to Article II limitations. It is fitting and proper that on this Veterans Day, that members of Congress honor all Veterans, who pledged an oath to protect and defend the Constitution of the United States against all enemies both foreign and DOMESTIC, but especially to those that gave "their last full measure of devotion" by standing up FOR the US Constitution and stand up TO Donald Trump.
