**SUBJECT: CONSTITUTION PARTY OF VIRGINIA CHAIRMAN URGES DEMOCRATIC SENATORS MARK WARNER AND TIM KAINE TO CONFIRM AMY CONEY BARRET TO THE SUPREME COURT**

Constitution Party of Virginia Chairman, John Bloom, urges Virginia's Democrat Senators Mark Warner who is up for re-election this year, and Tim Kaine to **CONFIRM Amy Coney Barrett as Associate Justice to the Supreme Court.** Ms. Barrett was his first choice to the Supreme Court instead of one of the Architects of the **UNCONSTITUTIONAL** misnamed "Patriot Act" that has abused by the Federal Bureau of Investigation to allow them to obtain information with little to no justification and in the secret FISA Court was a POOR CHOICE in Brett Kavanaugh.

Too often Activist Judges do not read either the Constitution of the United States and laws passed by Congress as written. Based on Ms. Barrett's statement at her Confirmation Hearing she affirmed she would REVERSE the Decisions of Activist Judges and force Congress to do their Jobs. Ms. Barrett will not make Decisions that would allow Presidential Executive Orders that change laws passed by Congress, like the Affordable Care Act has been changed over 40 times or like Immigration laws have been changed by Donald Trump.

For those concerned with how Ms. Barrett will render a decision on overturning the Roe V Wade Decision on Abortion, the 10<sup>th</sup> Amendment reads as follows:

"The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people."

Therefore, there is nothing in the Constitution of the United States that even mention that the Federal Government has any Jurisdiction on Abortion, for those that do not like that, Mr. Bloom suggests those that disagree pass an Amendment allowing Abortion. If the Roe V Wade decision is reversed it just returns to THEIR State the Right to REGULATE Abortion. Just like the Missouri Compromise, there will be Slave/Abortion on Demand States and Free/Abortion Restricted States.

Then there is the misnamed Affordable Care Act, which had a statement that people ONLY in States with Obamacare State Exchanges are Eligible for SUBSIDES. That is the LAW DEMOCRATS passed. At the time Justice John Roberts cast the deciding vote, that allowed all those in America access to subsidies. This was done DELIBERATELY by the Democrats to force states to adopt an Obamacare State Exchange, which did not happen. Ms. Barrett will read the law and render a decision based on the law and return the law back to Congress to CORRECT the POOR LAW they passed and President Barrack Obama signed into law, all done hastily, prompting Speaker of the House Nancy Pelosi to say "We need to pass it so we know what's in it." What an arrogant, yet TRUTHFUL thing to say, as Republicans and Democrats pass laws all the time without ever reading a page.
