**SUBJECT: THE PT BARNUM OF THE REPUBLICAN PARTY AND THE DEMOCRATS "GREATEST SHOW ON EARTH"**

The Chairman of the Constitution Party of Virginia issues the following statement in regard to the International Embarrassment that occurred at the US Capital on January 6<sup>th</sup>, 2021:

"The Republican PT Barnum, Donald Trump, and his Mob of SUCKERS that stormed the US Capital was an International embarrassment that needs to be addressed by Congress. The following actions must be taken immediately to protect, defend and preserve America's Constitutional Republic for America's posterity:

1. **I urge The House of Representatives to IMPEASH Donald Trump for Abuse of Power in his attempt to strong-arm the Republican Georgia Secretary of State to "find" votes that would enable him to win the State's Electoral vote AND for Orchestrating a Conspiracy by calling in supporters to come to Washington DC and encouraging them to storm the Capital, in what some Republicans have called an attempted coup, which left four people dead.** I informed supporters of the Constitution Party of Virginia to not attend the "Unite the Right Rally" in Charlottesville to avoid confrontation and was asked if I planned to attend this UNCONSTITUTIONAL Event, though I thought it would result in confrontation, I did not expect people to die.
2. I expect the Democrat Senate to have a swift Impeachment Trial that would include Republican witnesses for the Prosecution, along with audio and video tapes that would make the Democrat Controlled **SENATE IMPEACHMENT TRIAL "THE GREATEST SHOW ON EARTH"**.
3. Do NOT accept the President's Resignation to avoid him being removed from office for **if Donald Trump is removed from office, he prohibited from running for any public office ever again and if only 17 Republican Senators were to vote for Conviction, there would be a chance for them to take the Republican Party back from the Trumpicans** as Donald Trump would no longer be able to benefit from challenging those Republicans in a Primary that stood up for the Constitution of the United States.
4. What happened on January 6<sup>th</sup>, 2021, would have only been possible if Republican Members of the House and Senate VIOLATED their oath of office to defend the Constitution of the United States against all enemies both foreign and domestic as the Constitution does not allow members of Congress to object to counting of the votes, in accordance with the 12<sup>th</sup> Amendment of the Constitution of the United States. **Therefore each member of Congress that objected to the counting of the Electoral votes the House of Representatives should impeach them all for their part in the storming of the Capital.** That would include Ted Cruz, who I supported for President in 2016 and even had then Chairman of the Republican Party of Virginia back then, John Whitbeck to sign his Republican Presidential Nominating Petition. I have this advice to Senator Cruz, he needs to take lessons on the Constitution from Lindsay Graham.
5. I appeal to the Federal Bureau of Investigation to charge each and **every one that stormed the Capital of TREASON**, that was NOT a protest, but an act of insurrection and Treason.
6. For those Republicans in Virginia, that desire a pro-life Constitutional Alternative to the Republican Party, **I am extending an offer not to just join the Constitution Party of Virginia, but consider being a candidate of this political party, this year and run for State Delegate or next year to run for Congress."**
