SUBJECT: PRESIDENT JOE BIDEN SHOULD PRESENT MIKE PENCE WITH THE PRESIDENTIAL MEDAL OF FREEDOM AND CONGRESS SHOULD EXPEL THE TRAITORS IN CONGRESS WHO SET UP THE BIG LIE THAT DREW THE MOB TO DC
