SUBJECT: CHAIRMAN OF THE CONSTITUTION PARTY OF VIRGINIA HAS SEEN ENOUGH EVIDENCE TO JUSTIFY IMPEACHING AND REMOVING DONALD TRUMP AS PRESIDENT

John Bloom, Chairman of the Constitution Party of Virginia, as a Former Newport News Republican City Vice Chairman has seen enough evidence provided by the testimony of witnesses in the Impeachment Inquiry to justify pass Articles of Impeachment against Donald Trump by the House of Representatives and Removal from office by the US Senate.

- The Impeachment process is not about the President of the United States committing a statutory crime, but the CLEANSING of the office of the Presidency, as Republican Senator Lindsey Graham said when President Bill Clinton was Impeached by the Newt Gingrich led Republican Controlled Congress over President Clinton lying about an affair with an Intern.
- What should be obvious to most objective individuals is that what Donald Trump did involved Foreign Policy, using Taxpayer funds authorized by Congress for Military Aid to the Ukrainian Government so it can protect itself from Russian aggression.
