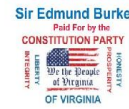

**SUBJECT: ALL STATE LAWS REQUIRING ADDITIONAL REQUIREMENTS TO RUN FOR PRESIDENT AND CONGRESS ARE UNCONSTITUTIONAL**

Constitution Party of Virginia Chairman John Bloom Mr. Bloom after hearing about the debate between two CHILDREN over the age of 70, Democrat gaffe Machine Joe Biden and Republican Pathological Liar Donald Trump, it was obvious it was NOT a **Presidential** Debate, Though Mr. Bloom is well versed in the Constitution of the United States, he re-read again and realized all state laws that restrict Ballot Access for Federal Offices are totally UNCONSTITUTIONAL. The Framers of the US Constitution so feared political parties, restricting the Individual Rights of its Citizens that they do not even address political parties. They hoped that the National Platform would be the Constitution of the United States, which the Constitution Party of Virginia adopted as its National Platform and the Virginia Constitution is the State Platform. What our Framers feared is OUR REALITY.

Though Mr. Bloom led to fight to gain ballot access for several candidates by waving the SIGNATURE requirements during the Coronavirus Pandemic, Barrack Obama appointee Judge John Gibe reduced the signature requirements from 5,000 signatures down to 2,500. Mr. Bloom, who is at high risk of contracting the Coronavirus, testified that forcing third party candidates for President to risk public health and spreading the Coronavirus throughout the state of Virginia, during the time that the Coronavirus increased all across Virginia. The Democrat Governor Ralph Northam who had no problem restricting Virginians right to freely assemble and required Virginians wear masks in Public to reduce the spread of the Coronavirus, but did not remove these signature requirements to just to gain ballot access to reduce spreading the Coronavirus statewide. Therefore only Libertarian Party Nominee for President Jo Jorgensen is the only other candidate on the Presidential Ballot and that was because they were able to collect 1,500 before the Governor gave his "STAY AT HOME" order that according to representatives that testified at the hearing, did NOT apply to collecting signatures as if petition carriers and those they approached to sign a petition, were inoculated with a Corona-19 vaccine that doesn't exist yet.

Here is what the Constitution of the United States requires under Article II, Section 1:

"No person except a natural born citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution shall be eligible to the Office of President of the United States; neither shall any person be eligible to that office who shall not have attained to the Age of **thirty five** Years and have been fourteen Years a Resident within the United States."

Those are the ONLY requirements to run for President of the United States, there are similar words for members of the House of Representatives and US Senate. States can regulate the requirements for State offices, but NOT for President and members of Congress.

Most Americans are unaware those are the requirements to run for these Federal Offices are defined in the Constitution. In the 1960s the Democrat and the Republican Parties conspired to pass laws to restrict **COMPETITION** within their respective states after the Democrat Segregationists led by Alabama Governor George Wallace created the American Independent Party. George Wallace Democrats are the base of the Party of Trump.

The Next "Presidential" Debate needs to include AN ADULT, Ms. Jorgensen at least, who is on the ballot in every state. The moderator must turn off the microphone for those that have excessively exceed their allotted time, and when they are NOT responding to a question the moderator asked them, to prevent continual interruptions from the 70 year old CHILDREN. If those conditions are NOT met the other the debates will NOT be Presidential. Mr. Bloom is nearly 60 years old, with the Gaffe Machine and the Pathological Liar, neither of them represents him, members of the Constitution Party of Virginia and most people under 60.
